NOTICE TO EXHIBITORS

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a **\$25.00** collection fee to the amount of each returned check.

ENTRIES close Wednesday January 11, 2023 at 6:00 pm. All entries must be on an AKC Official Entry Form and must include the Agreement and Instructions on the reverse side. Entries will not be accepted without the proper form, signature, fees, or if the entry specifies any condition as to its acceptance. Incomplete, inaccurate, or illegible entries will not be accepted. Telephone, email, or faxed entries will not be accepted. Selected trials must be checked or circled. All American Dogs that are listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form.

Please note there are separate entry forms for Obedience and Rally. Please type or print legibly.

LIMITS: Saturday and Sunday entries will be limited in accordance with Chapter 1 of the AKC Obedience and Rally Regulations. Entries will be processed in the order received and time limits calculated for each judge until the daily judging limit is reached or entries close. Obedience UDX and Rally RAE Class entries will be given priority.

JUMP HEIGHT: All classes requiring jumps will be arranged in jump height order. Saturday and Sunday judging will begin with the 4 inch jump height and continue in ascending order. If you are entering any of these classes jump height is a required part of your entry. Please refer to AKC Obedience Regulations for the description of classes, eligibility, and proper jump heights.

ERRORS ON ENTRIES: Owners are responsible for the accuracy of the information required on the entry form. Changes, additions, or corrections to an entry, entry substitutions, or cancellations by the owner must be received in writing by the Trial Secretary prior to the closing date of the trial. Other means of notification will not be accepted.

REFUNDS: All requests for the refund of Trial or Match entry fees must be received before the closing date. A refund of entry fees will not be given in the event a dog is absent, disqualified or excused by a veterinarian or judge, or barred from competition by action of the Trial Committee; or if the trial cannot be opened or completed by reason of riots, civil disturbances, extreme and/or dangerous weather conditions, or any emergency or other cause beyond the control of the Club.

Entry fees, less a \$10.00 per trial processing fee, will be refunded for bitches that come in season after the closing date. A written refund request from the owner accompanied by a signed and dated verification from a veterinarian must be received by the Trial Secretary no later than one hour prior to the start of the first class in the trial. Bitches in season are not permitted at the show site at any time.

TRANSFERS: Transfers are permitted in accordance with Chapter 1 of the AKC Obedience and Rally Regulations. A request for a Transfer must be in writing and given to the Trial Secretary at least 30 minutes prior to the start of each trial. Transfers prior to the day of the Trial will be accepted. Forms will be available at the Trial Secretary's table.

RALLY RING: The Rally ring will be 40 x 60 feet.

JUDGING: The Judging Program will be sent to exhibitors approximately one week prior to the Trial. Judging schedule conflicts should be resolved with the judge at the trial, at least 30 minutes prior to the start of the class.

It is the exhibitor's responsibility to be ringside ready to enter the ring when called. Neither the Trial Secretary nor the stewards are obligated to notify any exhibitor when they are due in the ring for judging. Judges are not required to wait for any exhibitor. Dogs need be present only for scheduled judging and will be released if not needed for further judging.

SHOW SITE: All dogs must be held on a leash or confined to a crate except when in the ring for judging. Dogs must be on a leash when being exercised, trained or when warming-up. Please maximize available crating space but **do not crate within 10 feet of the ring gates**. Dogs must be removed from the building immediately following the end of the Trial. FFDTTC reserves the right to remove any dog in distress in a parked vehicle or crate. Please keep the grounds clean by picking up after yourself and your dog. An exercise area outside the facility will be plainly marked. Use this area only and dispose of "poop bags" in the trash containers provided there. Please keep your crating area, the trial site, RV grounds, and motel rooms and grounds clean so we may continue to be welcomed at these facilities.

CONDUCT TRIAL/MATCH: It is expressly understood that all owners/agents/exhibitors are solely responsible for the behavior of their dogs and/or children. Any person(s) whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior will be asked to leave the trial site. In such cases the Club will not refund any fees or monies previously paid.

Owners/agents/exhibitors engaged in conduct prejudicial to the best interests of the Sport of Obedience, AKC events or the AKC will be asked to leave the trial site or brought before the Event Committee depending upon the seriousness of the offense. In such cases the Club will not refund any fees or monies previously paid.

All owners/agents/exhibitors and other persons attending these trials hereby waive any claim against the Club or its agents, for any losses, damages, or injuries affecting self, dogs, children, or personal property.
