ENTRIES CLOSE ON March 5, 2025 at 6:00 pm EST after which time entries cannot be accepted, canceled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be shredded. The sender will be notified after opening day entries are processed.

Move-ups will be offered between trials. Move ups from Saturday to Sunday must be submitted before the end of the trial on Saturday!

No run order adjustments/move ups will be made Sunday morning, trial 1. Moved up dogs will run last.

HANDLER DISCRIMINATION

Handler Discrimination classes are titling classes in which the targeted scent is that of the handler themselves. Handlers are required to provide their own scented articles in a plastic bag, for the Novice class, one cotton glove or cotton sock, for Advanced, Excellent, and Master, cotton balls or cotton swabs. Three qualifying scores are required to earn titles in each class.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges(including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

Club Vouchers (Sand Dollars) may be used for up to 50% of entry fees. Sand Dollars must be sent at the time of entry to be valid as payment.

No entries will be accepted by phone, email, fax, or hand delivery. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Inquiries may be directed to Andrea Defibaugh at heyjudetrialsec@gmail.com. No entry shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance.

UPS and FedEx entries will not be accepted as they cannot deliver to a PO box.

Illegible entries will not be processed and will be shredded. Returned/bounced checks do not constitute a valid entry and will incur \$50.00 collection fee.

Entries not admitted to the trial and withdrawn entries will be shredded; not be returned to the exhibitor. If you want your payment method returned in the event of withdrawal, please include a self addressed, stamped envelope with your entry!

Please do not staple your entries and checks together.

DO NOT USE OLD ENTRY FORMS OR OAKLINES.

WAIT LIST INFORMATION

A wait list of 50 runs per trial will be maintained until the wait list closing date listed on page 1, after which time, no changes, alterations, substitutions, or backfills will be made to the trial entry list. Any runs not admitted to the trial by the Wait List Close Date above will be refunded.

CLOSING DATE. No entries may be withdrawn with a refund after closing. All entries must be received by trial closing. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund. If you do not wish to commit to a run you must withdraw from the wait list before trial closing.

Withdraw/Wait List updates will conclude March 14, 2025, 6 pm.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include crating, warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

Warm-up area: The club shall designate a warm-up area. One labeled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers. Warm up boxes are NOT to be used for training purposes.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions: Searches may be indoors, on matted, carpeted, concreted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces. Surfaces may be uneven, slick/smooth, or naturally hazardous (eg: tree roots). Navigation to search areas may include ramps, stairs, or elevators as necessary. Additional information about search area conditions will be made available at each briefing.

Search Area Sizes will be as specified in AKC Scent Work regulations.

ADDITIONAL SITE INFORMATION

Trial Limit: Trial will be limited to 187 entries per trial/374 per day. Judges are limited to 125 runs per the AKC regulations. Assignments may change for load balancing, if necessary.

Trial Site: It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Potty Area: is in the designated area in the front of the buildings. **Exhibitors are responsible for using appropriate potty area and cleaning up after their dog(s).** Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Possession of Odors and Training: Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area: Reasonable accommodation will be made for spectators. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run. No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be asked to leave the area by the judge. Spectators are forbidden to discuss details of the search with handlers who have not run.

Crating space: Exhibitors will need to crate out of their vehicles for this trial.

Parking: Ample parking is available, no RV hook-ups available. No overnight parking.

Smoking and Alcohol: The venue is a smoke and alcohol-free area. Do not smoke on the property.

Food and Concessions: Exhibitors should bring their own lunch, snacks, and beverages if desired. There are a few restaurants and convenience stores within reasonable driving distance.

While not actively searching, dogs MUST be on a fixed length 6' or shorter leash, INCLUDING entering and exiting search areas in order to avoid dog to dog contact. Flexi leads are not permitted on trial grounds with the exception of inside the search area ONLY. Your dog may NOT leave the search area on a retractable leash of any kind.

RIBBONS, AWARDS, AND PRIZES

Placement ribbons will be awarded in each class as follows:

First Place	Blue
Second Place	Red
Third Place	Yellow
Fourth Place	White
Qualifying Score	Dark Green

New Titles will be awarded with double flat ribbons.

Super Sniffer: Teams must qualify in all odor division elements, regardless of level split, in a single trial. Super Sniffer award is a scent work themed item such as a sticker or magnet and a flat ribbon. Sponsored by Hey Jude Creative.

Detective Qualifiers will receive a custom rosette from Hodges. Additional details for receiving your custom rosette can be directed to the Trial Chair.

Judge's Choice: Teams exhibiting exemplary teamwork can be awarded a Judges Choice flat ribbon. This award is presented at the discretion of the judge.

Ribbons and prizes will not be mailed.

HIGH IN TRIAL (HIT) & HIGH COMBINED DIVISION (HCD)

HIT: Teams must enter and qualify in all standard titling elements offered within the same level. HIT is awarded to the team with the fewest faults and fastest cumulative time. HIT is awarded in each level. Novice A and B are scored together and only one HIT will be awarded for Novice.

High in Trial cannot be scored before all classes in a given level are completed.

Teams winning HIT will earn a Rosette from FFDTTC and prize from Hey Jude Creative.

HCD: Only teams who participate in the same difficulty level in all elements plus Handler Discrimination, and qualify in each, are eligible to win High Combined Division. The High Combined Division award is determined by adding a team's faults across all classes. The team with the fewest faults will be declared the winner of the High Combined Division. The High Combined Division award is not recorded by the AKC.

Teams winning HCD will earn a Rosette from FFDTTC.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR AND LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Five Flags Dog Training Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Five Flags Dog Training Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Five Flags Dog Training Club or any official thereof.

Collars, Leashes and Harnesses: **While not actively searching, dogs MUST be on a fixed length 6' or shorter leash, INCLUDING entering and exiting search areas in order to avoid dog to dog contact.** During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

Refunds will be mailed by the club after the trial concludes. FFDTTC does not make refunds under \$10 - check your entry fees!

Refunds of Club Vouchers will be handled by the Volunteer Coordinator and Trial Committee.

Entries not admitted to the trial and withdrawn entries will be shredded, not be returned to the exhibitor.

Request for returned checks and money orders must be made in writing to the Trial Secretary by email before the closing date and a self addressed and stamped envelope must be provided by the exhibitor.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: Once the procedure for check-in is determined all exhibitors will be notified by email in the official welcome letter.

Exhibitors MUST check-in EACH day they are entered.
Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.



Entry FAQs

Should I enter Novice A or B?

Novice A is for beginners, B is for dogs that have titled in AKC Scent Work OR a comparable event in another venue OR handlers who are professional K9 handlers OR Scent Work Judges. Obedience, Rally, Agility, etc. titles do not factor into B status.

If you title in Novice and would like to STAY in Novice for Elite legs, you MUST move to Novice B.

How many times can I enter?

You can enter as many elements as you want. You may enter up to 2 levels in the same element per trial event. If you enter more than 2 levels, the highest 2 will be counted.

For further information, please see page 7, Ch 2, Sec 2 of the AKC Scent Work Regulations.

How do I get High in Trial?

To be eligible for High In Trial you must enter all offered elements in the same level AND qualify in ALL elements. The HIT is the team with the fewest faults in the fastest cumulative time. Novice A and B are scored as one class for HIT.

What's a Super Sniffer and how do I win it?

To be eligible for Super Sniffer you must enter all offered elements in any level combination AND qualify in ALL elements. Essentially - you must qualify in all offered odor classes offered for that trial, regardless of level.

What time will I run?

Tentative class counts and a schedule will be emailed out after wait list closing. These times are estimates and provided as a courtesy - they are not guaranteed times.

HOTEL AND CAMPGROUND INFORMATION

It is recommended that you confirm with the hotels as to whether they allow dogs, have size or weight restrictions or any additional fees. Exhibitors are expected to follow all hotel rules.

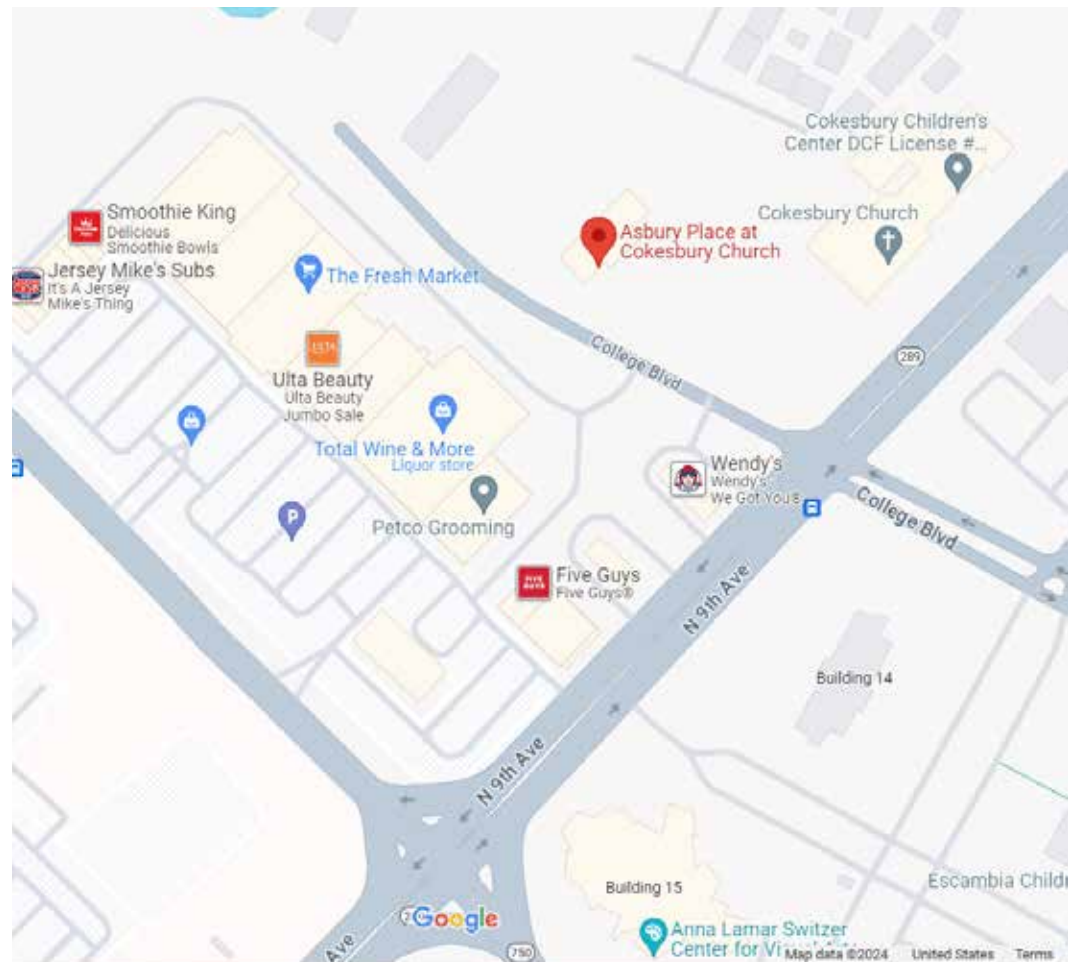
